Note: The nominated qualified witness must reside in the same state as the origin of the supporting documentation and the applicant.

Your personal information is collected for the purposes of processing your claim in relation to the Unclaimed Money Register. Queensland Public Trustee (QPT) is committed to your privacy and your personal information will not be released to any person unless you authorise such action or the release of the information is required by law.

Proof of identity and association

Copies of proof of identification documents and association documents sent to us with your application must be certified as a true and correct copy by a qualified witness.

The following people are qualified witnesses and are able to certify photocopies of documents:

In Australia

- Justice of the Peace
- Commissioner for Declarations
- Barrister, solicitor or Notary Public
(or any other approved witness in your jurisdiction)

Outside Australia

- Notary Public
- Australian Embassy Officer
- Australian Consulate Officer

Where funds are held in more than one name, each party must complete a separate claim form and provide identification. For multiple register entries, only one application form and one set of identification and supporting documents are required to be submitted per person or company.

Section 1: Identification of person

If the applicant's name differs to the name that is listed in the unclaimed register, we also require documented evidence of the applicant's name change/s. Such document/s must be official registry documentation and not a ceremonial certificate. QPT will conduct identity verification processes at its discretion, at no cost to the applicant.

You must provide **four forms of current identification**:

1. Photo identification:

This includes a certified copy of one of the following: driver licence, passport or Adult Proof of Age card.

2. Community identification:

This includes a certified copy of one of the following: Medicare card, birth certificate, bank card, student card, salary advice or payslip, Blue Card.

3. Current residential address evidence:

This may include a certified copy of utility bill or rates notice.

4. Bank account evidence:

This is a certified copy of a bank statement that includes the applicant's name and residential address, and matches the account details in the application.

Section 2: Proof of association

All claims require two proofs of association evidence.

A proof of a connection to the organisation that sent the unclaimed money to QPT is required.

1. Provide a certified copy of a linking document demonstrating your connection to the unclaimed money.
2. Provide certified proof of the applicant's last known address held by the sender organisation.

Section 3: Deceased estates

A separate completed application form together with certified identification documents must be provided by all executors or administrators. Proof of association documents described in **Section 2** are also required.

The following supporting documents will also be required:

A certified copy of the death certificate, a certified copy of the deceased's Will and where applicable, a certified copy of Grant of Probate or Letters of Administration.

If no Grant of Probate or Letters of Administration have been obtained, a Statutory Declaration confirming that no legal proceedings have commenced relating to the estate and that the executor does not intend to start any formal legal estate administration will need to be completed by all executors.

Please note: Depending on your claim, QPT may request that you obtain a Grant of Probate or Letters of Administration. Funds will be paid into bank account in the name of the estate or a cheque made out to the estate if there is no bank account.

Section 4: Companies



Company applications for unclaimed money must be completed by at least two officers of the company (either two Directors or one Director and one Secretary for example). These are the people listed on the company record, held by Australian Securities & Investments Commission (ASIC) as either a CEO, Director or Secretary. Such person(s) must also satisfy the requirements of **Section 1** and **2** above in full.

You will also be required to provide a certified **Current Company Extract** or **Historical Company Extract** issued in the last 30 days from ASIC showing the Office Bearers (where applicable, the company seal should be affixed).

Section 5: Claims lodged by an agent (money finder)



Where an agent (money finder) is making a claim on behalf of the owner of unclaimed money, a cover letter from the agent **and** the original signed agency authority must also be provided. Identification and supporting documents of the owner of the funds must also satisfy the requirements of Section 1 and 2 above in full.

IMPORTANT NOTICE

QPT will not pay any claim until a completed Unclaimed Money Application Form and all supporting documentation is received.

QPT reserves the right to call for additional supporting documentation.

Where an application is incomplete, QPT may contact the applicant to advise what additional documents are required. Applications will not progress until those additional documents are received by QPT.
